

**TOWN OF SOMERSET, MA
SPECIAL TOWN MEETING
NOVEMBER 14, 2016**

The Special Town Meeting of November 14, 2016, was called to order at 6:05 pm by the Town Moderator Lucia Casey. The Pledge of Allegiance was led by the Moderator.

Article 1: To see if the Town will vote to amend its vote on Article 5A of the May 16, 2016, Annual Town Meeting, for the purposes of the General Budget for Fiscal Year 2017, the appropriation for which was originally voted as follows:

from Taxation: \$22,956,898.00
from Municipal Waterways Improvement and Maintenance Fund: \$9,030.00
for a Total Appropriation of \$22,965,928.00

by transferring and appropriating additional sums of money from available funds and by reducing the amount to be raised from taxation by the equivalent amount.

The Advisory & Finance Committee unanimously recommends that the Town vote to amend its vote on Article 5A of the May 16, 2016, Annual Town Meeting for the purposes of the General Budget, as follows: by reducing the amount of money to be raised from taxation from \$22,956,898.00 to \$18,548,700.00, a decrease of \$4,408,198.00, and by transferring the amount of \$4,408,198.00 from Undesignated Surplus.

The manner of giving notice of a Town Meeting shall be by posting attested copies of the warrant relating thereto at five (5) suitable places, one (1) in each precinct in the Town, at least seven (7) days before the holding of an Annual Town Meeting and at least fourteen (14) days before the holding of a Special Town Meeting.

Article 23: To see if the Town will vote to amend the Somerset Zoning By-law by making changes to section 6.10 (Planned Developments) as follows:

By deleting the existing language in the first sentence of section 6.10.1, which presently reads:

For the purposes of this By-law, planned development shall mean the following uses in any district other than a Light Industrial or Limited Business District:

And replacing it with the following:

For the purposes of this By-law, planned development shall mean the following commercial and industrial uses other than in a Light Industrial or Limited Business District:

And by adding the following new subsections d, e, and f after the existing provisions in section 6.10.1:

- d. Use of a lot where there is construction, exterior alteration or expansion, or change of use involving more than five hundred square feet;
- e. Construction, expansion or relocation of a parking lot, the relocation of existing parking spaces, or the relocation of any site entrance;
- f. Any new use that is accessory to the principal use.

The Planning Board will have a recommendation at Town Meeting. A favorable recommendation was given by PB Chairman Gary Simons.

Motion by Gary Simons, Planning Board: I move that the Town vote to amend section 6.10 (Planned Developments) of the Somerset Zoning By-law, by making the changes set forth in Article 23.

2nd by: Selectman Moniz

Discussion by: Attorney Brown on behalf of the Building Inspector who brought this article to the Planning Board for approval.

Article 24: To see if the Town will vote to amend the Somerset Zoning By-law by making the following changes to section 2.0 (Definitions) by adding the following new definition to the By-law:

Lot Width. Lot width is defined as the distance between the sidelines required allowing a circle to be placed between the sidelines. The required circle shall be tangential to the frontage of a given lot and shall be entirely contained within the lot boundaries. For lot frontage requirements of 100 feet, the circle diameter shall be 80 feet.

And by making the following changes to section 5.2 (Table of Dimension Requirements):

--Add "See Note 6" to the table in the horizontal column labeled "Minimum Frontage in Feet" under each category with a 100-foot frontage requirement

--After the Table, under the heading "Notes", add a new Note 6 as follows:

- 6. With regards to lots with a required frontage of 100 feet, see "Lot Width" definition.

The Planning Board will have a recommendation at Town Meeting. A favorable recommendation was given by PB Chairman Gary Simons.

Article 25: "To see if the Town will vote to adopt a "School-day Sidewalk Snow Clearing By-law", as follows:

It is the responsibility of every abutter of a publicly maintained sidewalk to keep sidewalks abutting his or her property free of snow and ice on any day in which public schools are in session. The responsibility includes connecting unimpeded pedestrian access to the sidewalk of adjacent abutters and to any crosswalks and wheelchair- access ramps built into the abutting sidewalk curb, or, in case of sidewalks without adjacent crosswalks or wheelchair access ramps, to abutting street corners.

Any abutter who is both physically and financially unable to clear snow and ice from his or her property shall be absolved of this responsibility after both informing the Town Clerk or his or her physical and financial inability and requesting volunteer assistance to clean snow and ice from his or her property and abutting sidewalks. The Town Clerk shall publicly post all such requests.

Any individual or organization may clear a public sidewalk of snow and/or ice and be held harmless for throwing the removed snow and/or ice onto abutting property if said sidewalk has not been cleared previously as required, and if the removed snow and/or ice is thrown in a reasonably cautious manner to minimize damage, or inconvenience to sidewalk abutters."
