

**ANNUAL TOWN MEETING  
MAY 16, 2016**

Article 1: To choose all Town Officers as required by law, to be chosen by ballot.

**This article has been taken care of in the election of May 9, 2016.**

Article 2: To see if the Town will vote the following consent calendar of routine Annual Town Meeting Articles:

- A. To hear the report of the Town officers and act thereon;
- B. To authorize the Collector to use the same means which a Treasurer may use when acting as Collector;
- C. To hear and act on the report of any Committee and choose any Committee the Town may think proper;
- D. To authorize the Board of Selectmen to accept and enter into contracts for the expenditure of any funds allocated or to be allocated by the Commonwealth and/or the County for the construction, reconstruction and improvement of Town roads, pursuant to the terms of said funding.

**The Advisory & Finance Committee unanimously recommends approval of this article.**

**Motion: A motion was made by Selectman Berube and seconded by Selectman Moniz that the Town adopt article 2, as written and recommended. Vote: Motion carried by unanimous vote.**

Article 3: To see if the Town will vote to authorize the following revolving funds to continue for the Fiscal Year July 1, 2016 to June 30, 2017, under the provisions of Massachusetts General Law chapter 44, section 53E1/2:

A motion was made by Lloyd Mendes, 46 Anawan St, to amend Article 4 by reducing each annual salary on the table by 10%, following he stated the salaries as proposed with the reduction of 10%. There was a 2<sup>nd</sup> on the floor. Discussion followed by Mr. Mendes, Phyllis Burnside and Mr. Mendes again. A motion was made by a member of the body to move the question. There was a second on the floor. Following a nearly unanimous vote, the Moderator called for the vote on the motion to amend. The motion failed by a nearly unanimous vote. The Moderator opened the floor to discussion on the original motion. Following no further discussion, the vote was taken. Vote: Motion carried by a nearly unanimous vote to accept Article 4 as written and recommended.**

The Advisory & Finance Committee will have a recommendation at Town Meeting. At the meeting A & F Chairman Christopher Godet declared that Advisory & Finance Committee unanimously recommends approval of this article.

Motion: A motion was made by Mr. Berube and seconded by Mr. Godet that the Town vote to appropriate the sum of \$22,965,928.00 for the fiscal year July 1, 2016 to June 30, 2017, for the purposes of the General Budget as designated and that said sum be transferred and raised as follows: by transferring \$9,030.00 from the Municipal Waterways Improvement and Maintenance Fund and raising \$22,956,898.00 from taxation. Discussion followed by Mr. Berube. A motion was made by Mr. Lloyd Mendes, 46 Anawan Street, that the Town vote to reduce line item #220 personal services by \$38,075. There was a second on the floor. After discussion by Selectman Berube, Selectman Moniz, Chief Jepson, and Mr. Mendes, a motion was made to move the question. There were several seconds from the voting body. The Moderator called for the vote on the motion to amend Article 5A. The motion failed by a nearly unanimous vote. The Moderator opened the

floor for discussion on the original motion. In the absence of further discussion, the Moderator called for a vote. **Vote:** Motion carried by a nearly unanimous vote to accept Article 5A as written and recommended.

The Advisory & Finance Committee unanimously recommends approval of this article.

**Motion:** A motion was made by School Committee Chairman Arastou Mahjoory and seconded by Robert Lima that the Town vote to appropriate the sum of \$18,854,776.00 for the fiscal year beginning July 1, 2016 and ending June 30, 2017, for purposes of funding the Somerset Public School Department Budget as designated, and that said sum be funded through taxation and other available funds. Discussion followed by Mr. Mahjoory. There was a motion by Mr. Lloyd Mendes, 46 Anawan Street, to reduce the Operating Expenses by \$30,000 by reducing one bus route. Discussion followed on the motion to amend by Mr. Mendes, Superintendent Schoonover, and again Mr. Mendes. In the absence of further discussion on the amendment, the Moderator called for a vote. The motion to amend failed by a nearly unanimous vote. The Moderator opened the floor for discussion on the original amendment. In the absence of further discussion, the Moderator called for the vote. **VOTE:** Motion carried by a nearly unanimous vote to accept Article 5B as written and recommended.

**Motion:** A motion was made by Scott O'Brien and seconded by Mr. Lima that the Town vote to appropriate the sum of \$3,355,624.00 for the fiscal year July 1, 2016 to June 30, 2017, for the purposes of this article and that the sum of \$3,355,624.00 be raised from Water Enterprise Fund Receipts. There was no discussion. **Vote:** Motion carried by a unanimous vote to accept Article 5C as written and recommended.

**Article 6:** To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the Unused Sick Leave Account as provided in the Consolidated Personnel Bylaw, Article II, Employee Benefits, Section I, Sick Leave.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$11,000)**

**Motion:** A motion was made by Selectman Moniz and seconded by Mr. Godet that the Town vote to appropriate the sum of \$11,000 for the purposes of this article and that said sum be raised from taxation. Discussion followed by Selectman Moniz. **Vote:** Motion carried by a nearly unanimous vote to accept Article 6 as written and recommended.

**Article 7:** To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the purpose of paying the Town's share of the operating expenses of \$7,384,459.00 and capital expenses of \$1,486,892.00 for a total of \$8,871,351.00 for the **Somerset-Berkley Regional School District**, said amount having been assessed to the Treasurer of the Town of Somerset.

**The Advisory & Finance Committee will have a recommendation at Town Meeting.**

**Motion:** A motion was made by SBRSC Chairman Richard Peirce and seconded by Mrs. Gagliardi that the Town vote to appropriate the sum of \$8,871,351.00 for the purpose of paying the Town's share of operating expense for the Somerset Berkley Regional School District, said amount having been assessed to the Treasurer of the Town of Somerset and that said sum be raised from taxation. Discussion followed by Mr. Peirce and Superintendent Schoonover. A motion was made by Mr. Lloyd Mendes, 46 Anawan Street, to amend the Operating Expenses by \$56, 162.00 reducing the total appropriation to \$8,815,181.00. Discussion on the motion to amend followed by Mr. Mendes and Mr. Peirce who called the motion to amend not in order per Massachusetts General Laws. The Moderator agreed and ruled Mr. Mendes amendment out of order. The floor was opened for discussion on the original motion. In the absence of further discussion the vote was taken. **Vote:** Motion carried by a nearly unanimous vote to accept article 7 as written and recommended.

**Article 8:** To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the purpose of paying the Town's share of the operating expenses of the **Greater Fall River Vocational Technical High School District** as provided for by section 6 of chapter 697 of the Acts of 1962, said amount having been assessed to the Treasurer of the Town of Somerset.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$1,219,026)**

**Motion:** A motion was made by Selectman Moniz and seconded by Mr. Godet and several others on the floor that the Town vote to appropriate the sum of \$1,219,026.00 for the purposes of this article and that said sum be raised from taxation. Discussion followed by Selectman Moniz. **Vote:** Motion carried by a nearly unanimous vote to accept Article 8 as written and recommended.

Article 9: To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the purpose of paying the Town's share of the operating expenses of the **Bristol County Agricultural School** as provided for by section 82 of chapter 6 of the Acts of 1991, said amount having been assessed to the Treasurer of the Town of Somerset.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$55,593)**

**Motion: A motion was made by Selectman Moniz and seconded by Selectman Berube that the Town vote to appropriate the sum of \$55,593.00 for the purposes of this article and that said sum be raised from taxation. Discussion Followed by Selectman Moniz. Vote: Motion carried by a unanimous vote to accept Article 9 as written and recommended.**

Article 10: To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for Account #753 (Long Term Interest) and Account #710 (Maturing Debt) for the purpose of paying interest and principal relating to sewer infrastructure debt.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$218,512)**

**Motion: A motion was made by Selectman Moniz and seconded by Selectman Moniz that the Town vote to appropriate the sum of \$218,512.00 for the purposes of this article and that said sum be transferred from Water Enterprise Fund Retained Earnings raised by Sewer Infrastructure Fees. Discussion followed by Selectman Moniz. Vote: Motion carried by a unanimous vote to accept Article 10 as written and recommended.**

Article 11: To see if the Town will vote to raise, appropriate and/or transfer from available funds a sum of money for the expense of **collecting and disposing of mixed solid waste, recyclables, yard waste, and white goods** and to determine whether pursuant to M.G.L. chapter 44, section 53E, the appropriation for said expense will be offset, in part or in the aggregate, by the estimated receipts from the fees charges for rubbish bags pursuant to Article 10 of the February 8, 1993, Special Town Meeting, as well as funds raised by taxation or transferred from available funds in the Treasury.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$1,200,000)**

**Motion: A motion was made by Selectman Moniz and seconded by Selectman Berube that the Town vote to appropriate the sum of \$1,200,000.00 for the purposes of this article and that the sum of \$650,000.00 be raised from 'offset receipts', pursuant to MGL, chapter 44, section 53E, and that the sum of \$550,000.00 be raised from Taxation. Discussion followed by Selectman Moniz. Vote: Motion carried by a unanimous vote to accept Article 11 as written and recommended.**

Article 12: To see if the Town will vote to authorize the Board of Selectmen, pursuant to Massachusetts General Laws chapter 44, section 53E1/2, to establish a revolving fund for the Fire Department to collect and disperse funds in connection with Emergency Medical Services, to provide further that all fees and charges paid in connection therewith shall be deposited into said revolving fund, and to provide that without further appropriation, the Fire Chief may authorize disbursements from said fund during the upcoming fiscal year not to exceed \$1,200,000.00 to be used for Emergency Medical Services related expenses, and for any purposes incidental thereto.

**The Advisory & Finance Committee unanimously recommends approval of this article.**

**Motion: A motion was made by Selectman McNamara and seconded by Selectman Moniz that the Town so vote. There was no discussion. Vote: Motion carried by a unanimous vote to accept Article 12 as written and recommended.**

Article 13: To see if the Town will vote pursuant to M.G.L. chapter 44, section 53E, to specify that the appropriation for the annual ordinary operating costs of the Fire Department's Emergency Medical Services be offset, in part, by the estimated receipts from the fees charged to users of the services provided by said Department.

**The Advisory & Finance Committee unanimously recommends to indefinitely postpone this article based on the recommendation of Article 12.**

**Motion: A motion was made by Selectman McNamara and seconded by Mr. Godet that this article be indefinitely postponed. There was no discussion. Vote: Motion carried by a unanimous vote to indefinitely postpone Article 13 as recommended.**

Article 14: To see if the Town will vote to accept chapter 73, section 4, of the Acts of 1986, as amended by chapter 126 of the Acts of 1988, to allow an additional exemption which shall be uniform for a Surviving Spouse (Clause 17), for Veterans (Clause 22), for the Elderly (Clause 41C) and for the Blind (Clause 37), and none of which shall exceed seventy-five (75%) per cent of said exemptions for which they qualify for Fiscal Year 2017, or take any action relative thereto.

**The Advisory & Finance Committee unanimously recommends approval of this article.**

**Motion: A motion was made by Assessor Stephanie Schecter and seconded by Arastou Mahjoory that the Town so vote. There was no discussion. Vote: Motion carried by a unanimous vote to accept Article 14 as written and recommended.**

Article 15: To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the purpose of hiring expert and legal services to assist the Town on issues relating to valuation

and taxation of current and former electric and gas utilities and generating facilities, or take any other action relative thereto.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$50,000)**

**Motion: A motion was made by Assessor Stephanie Schecter and seconded by Selectman Moniz that the Town vote to appropriate the sum of \$50,000.00 for the purposes of this article and that said sum be raised from Undesignated Surplus. There was no discussion. Vote: Motion carried by a unanimous vote to accept Article 15 as written and recommended.**

Article 16: To see if the Town will vote to raise, appropriate, and/or transfer from available funds a sum of money for the purpose of data collection regarding residential and commercial permits, as required to satisfy the requirements of the Commonwealth of Massachusetts Department of Revenue.

**The Advisory & Finance Committee unanimously recommends approval of this article. (\$5,000)**

**Motion: A motion was made by Assessor Stephanie Schecter and seconded by Arastou Mahjoory that the Town vote to appropriate the sum of \$5,000.00 for the purposes of this article and that said sum be raised from Undesignated Surplus. There was no discussion. Vote: Motion carried by a unanimous vote to accept Article 16 as written and recommended.**

Article 17: To see if the Town will vote to authorize the Board of Selectmen to sell and transfer the parcel of Town-owned land and the building thereon located at 2435 Riverside Avenue, Somerset, (Assessors Map C-2, Lot 36), as further described below, on such further terms and conditions as the Board of Selectmen deems necessary, or take any action relative thereto:

A certain lot of land situated on the westerly side of Riverside Avenue, Somerset, MA, bounded and described as follows:

Beginning at the northeasterly corner thereof, in the westerly line of said Riverside Avenue, by land now or formerly of Frances Wells; thence running westerly by said last named land one hundred sixty-eight (168) feet more or less to land now or formerly of Charles W. Francis; thence southerly by said last named land sixty (60) feet for a corner and to land now or formerly of Thomas Hargreaves, Jr.; thence easterly by said last named land one hundred fifty-eight (158) feet more or less to said Riverside Avenue; and thence northerly along the westerly line of said Riverside Avenue sixty (60) feet to the point of beginning, containing thirty-three and 16/100 (33.16) square rods more or less.

**The Advisory & Finance Committee unanimously recommends approval of this article. (2/3 vote required)**
